Directions to Our Practice

From 285 East:



Merge onto I-285 E / GA-407 E via EXIT 259A. Take the GLENRIDGE DR exit- EXIT 26- toward GLENRIDGE CONN. Turn RIGHT onto GLENRIDGE DR NE. Stay STRAIGHT to go onto GLENRIDGE CONN NE. Turn LEFT onto JOHNSON FERRY RD NE. Turn RIGHT onto MERIDIAN MARK RD NE.

From 400 South:



Merge onto GA-400 S via the ramp on the LEFT toward ATLANTA (Portions toll). Take the GLENRIDGE CONNECTOR exit- EXIT 3- toward JOHNSON FERRY RD / PEACHTREE-DUNWOODY RD. Take the exit toward PEACHTREE-DUNWOODY RD. Merge onto GLENRIDGE CONN NE. Turn LEFT onto MERIDIAN MARK RD NE.

From 75 / 85 North



Merge onto I-75 N toward ATLANTA. Merge onto I-85 N / GA-403 N via EXIT 251 on the LEFT toward GA-400 / GREENVILLE. Merge onto GA-400 N via EXIT 87 toward BUCKHEAD / CUMMING (Portions toll). Take the GLENRIDGE CONN exit- EXIT 4A- toward I-285 E. Take the GLENRIDGE CONNECTOR exit toward PEACHTREE-DUNWOODY RD / JOHNSON FERRY RD. Take the

From 285 West:



Merge onto I-285 W / GA-407 W toward MARIETTA / CHATTANOOGA. Take the PEACHTREE-DUNWOODY RD exit- EXIT 28. Take the ramp toward GLENRIDGE. Turn LEFT onto PEACHTREE DUNWOODY RD NE. Turn RIGHT onto JOHNSON FERRY RD NE. Turn LEFT onto MERIDIAN MARK RD

From 400 North:



Merge onto GA-400 N (Portions toll). Take the GLENRIDGE CONN exit- EXIT 4A- toward I-285 E. Take the GLENRIDGE CONNECTOR exit toward PEACHTREE-DUNWOODY RD / JOHNSON FERRY RD. Take the ramp toward PEACHTREE-DUNWOODY RD. Merge onto GLENRIDGE CONN NE. Turn LEFT onto MERIDIAN MARK RD NE.
